Polling Locations on Tribal Lands

NRS 293.2733 and 293.3572 Requires City and County clerks to establish a polling location within the boundaries of an Indian reservation or Indian colony during a presidential preference primary, early voting or on election day. The Tribe may also elect not to have a polling place or drop box within the boundaries of a reservation or colony by submitting notice to the County Clerk. Please complete this form and submit it to the county clerk or registrar of voters in the county where the Indian tribe seeks to establish a polling place or opt- out. Opt-out requests for a presidential preference primary election must be received by September 15th of the year immediately preceding the year of the presidential preference primary election. Opt-out requests for a primary election must be received by January 15th in the year of an election. Opt-out requests for a general election must be received by June 15th in the year of the election.
