THE PEOPLE OF THE STATE OF NEVADA DO ENACT AS FOLLOWS

Section 1. Chapter 288 of the Nevada Revised Statutes is amended to read:

NRS 288.220 Certain proceedings not required to be open or public.

Proceedings, required by or pursuant to this chapter, are not subject to any provision of NRS which requires a meeting to be open or public:

- 1. Any negotiation or informal discussion between a local government employer and an employee organization or employees as individuals, whether conducted by the governing body or through a representative or representatives.
 - 2. Any meeting of a mediator with either party or both parties to a negotiation.
- 3. Any meeting or investigation conducted by a fact finder.
- 4. Any meeting of the governing body of a local government employer with its management representative or representatives.
- 5.] Deliberations of the Board toward a decision on a complaint, appeal or petition for declaratory relief are not subject to any provision of NRS which requires a meeting to be open or public.

Section 2. Section 1 of this initiative shall not apply to confidentiality provisions in any collective bargaining agreements in existence at the time of the enactment of this initiative.
