The People of the State of Nevada do enact as follows:

Charity Partner's Giving Foundation, a newly formed non-profit Nevada Corporation, seeks certain exclusive exemptions to the current statutes that govern charitable lotteries that are set forth in Chapter 462 of the Nevada Revised Statutes ("NRS") in order to harness online and legalize for charity purposes the common office betting pool.

CURRENT PROVISIONS: Currently the provisions restrict the conduct of the lotteries to within the State of Nevada. This includes the sale of the tickets of chances to participate in the lotteries. (NRS 180).

AMENDMENT WE SEEK: Headquartered in Nevada, Charity Partner's Giving Foundation, a philanthropic non-profit corporation will conduct common office pools online over the internet. This will enable Charity Partners to conduct fundraising globally.

CURRENT PROVISIONS: NRS 462.000 states that the net proceeds derived from a charitable lottery may only be expended by a qualified organization for the benefit of charitable nonprofit activities within Nevada.

AMENDMENT WE SEEK: In addition to the University of Nevada in Las Vegas and the University of Nevada in Reno sharing 20% of the annual net proceeds and another 15% of the annual net proceeds going to teachers and college students in grants, awards and zero-interest loans, other designated local and national charities such as Treatment and Research in Woman's Breast Cancer and Women's Heart Disease, The United Way, Habitat For Humanity, and others will benefit.

CURRENT PROVISIONS: Under NRS 462.140 the maximum value of all prizes that may be offered in charitable lotteries operated by a qualified organization during a Calendar year is \$500,000.

AMENDMENT WE SEEK: Charity Partners seek an unlimited ceiling on the value of all prizes that may be awarded in order to increase participation in fundraising events.

DESCRIPTION OF EFFECT

Nevada will benefit through financial support enabling the University of Nevada in Reno and UNLV to hold the line on tuition costs to relieve the burden on mothers and fathers, so that more students can benefit from a college education. Nevada teachers and students gain financially through grants, awards, zero-interest loans, and scholarships. Also local and national charities, and the needy people they help, will benefit. In addition, money will find its way to Nevada that otherwise would not. The Nevada economy will benefit. In each fundraising event 100 finalists win a trip for two to Las Vegas to attend a dinner where all cash awards will be made.
