

Nonresident or No Fixed Address 52 USC § 10502, NRS 293.5057, and NRS 41.191

If you do not maintain a residence in the State of Nevada, you may preregister or register to vote for the office of President and Vice President of the United States at the general election if you file a sworn statement (below) with the county clerk or field registrar of voters that you are not preregistered or registered to vote in any other state and provide evidence:

- 1. Of your domicile in this State, as defined in Nevada Revised Statute 41.191;
- 2. That you maintain an account at a financial institution located in this State; or
 - 3. That your motor vehicle is registered in this State. (NRS 293.5057)

This form permits voting at the general election for the offices of President and Vice President only.
