I understand that any person, either for himself or another, who: willfully gives false answers to questions relating to the required information on the voter registration application; willfully falsifies his registration application in particular; violates any of the provisions of the election laws of this state; or knowingly encourages another to violate such laws may be charged with a misdemeanor or felony, as applicable. I agree to return any unused applications.

If you are assisting a person to register to vote and you are not a field registrar appointed by a County Clerk/Registrar or an employee of a voter registration agency, You are required to provide your signature and to complete Box 14 of the Nevada Registration Application. Failure to do so may be considered a felony.

Completed Voter Registration Applications left in the custody of the person or organization conducting the drive must be returned to the county clerk/registrar within ten (10) days or by the close of registration preceding the next election, whichever is sooner.
