Notice of Designated Areas to Gather Signatures for Petitions
NRS 293.127565

Pursuant to NRS 293.127565, each public officer or employee in control of the operation of a building shall (a) designate the area at the building for the gathering of signatures; and (b) on an annual basis, submit to the Secretary of State and the County Clerk, for the county in which the building is located, a notice of the area at the building designated for the gathering of signatures on a petition. The Secretary of State shall make available to the public a list of the areas at public buildings designated for the gathering of signatures on a petition.

SUBJECT: Designation of Public Buildings to Gather Signatures on Petitions

Please be advised that you may be approached during the election year by individuals gathering signatures on petitions at our public building. Nevada law requires counties to designate an area in public buildings for petitioners to gather signatures on petitions.

NRS 293.127565 states the following:

“At each public building that is open to the public and occupied by the government of this State or a political subdivision of this State or an agency thereof . . . an area must be designated for the use of any person to gather signatures on a petition at any time that the building is open to the public.”

In accordance with this statute, the following building areas have been designated as locations where signatures may be gathered by petitioners in our public building:

<u>Building</u>	<u>Designated Area</u>
Minden Inn	Lobby between staircase and front window
Historic Courthouse	Sidewalk parallel to Eighth Street at entrance
Minden Library	Patio area outside main entrance
Judicial/Law Enforcement Building	In breezeway between secure entrance doors
Parks Building	Sidewalk between Parks/Weed and Cooperative Extension
Lampe Park	Sidewalk next to parking lot in front of Gazebo
Community and Senior Center	Outside of main entrance
Tahoe Service Center	Ground floor lobby next to Sheriff's counter
Kahle Community Center	Sidewalk on north side of main entrance
Gardnerville Town Office	On US 395 sidewalk by town office sign
Minden Town Office	Sidewalk left of entrance
Genoa Town Office	To the left of main entrance

Designated areas in public buildings other than those listed above will be identified on an as requested basis. The area designated above for the Kahle Community Center, the Historic Courthouse and Community and Senior Center will not be used during early voting and election days due to a state law that prohibits electioneering within 100 feet from the polling location (NRS 293.740). Election staff will determine an appropriate location for petitioners on those days.

While petition gatherers have the right to solicit individuals to sign a petition, they are to remain in the areas designated for signature gathering. Petition gatherers must not interfere with county operations in any way, hinder any person entering or exiting a county building, or obstruct access by public safety personnel.

Your help may be needed to remind petitioners to stay in the areas designated for signature gathering. Please escort petition gatherers back to the designated area if they wander.

Petition gatherers are supposed to contact the County Manager's Office in advance when they plan to gather signatures at our public buildings. When possible, I will send out a notice to employees when I learn that petition gatherers will be at any of our public buildings.
