The People of the State of Nevada do enact as follows 2012 FEB -8 PM 4: 22

Amendment Title: "The Right to Live for Young and Old ~~Like~~ VEGAS, NEVADA" AF

No person shall be deprived of life, liberty, or property without due process of law. As used in this section, the word "person" includes every human being from the beginning of biological development until death.

DESCRIPTION OF EFFECT

This Amendment enshrines the foundational civil right that no person shall be deprived of life, liberty, or property without due process of law, clarifying that the word person includes every human being throughout the continuum of life. Nevada has an arbitrary and discriminatory legal distinction between person and human being, as applied to the pre-born. This Amendment seeks to proactively correct this injustice and preemptively ensure that one's personhood may not be taken away for any reason throughout the entire continuum of life, regardless of age, ability, physical or mental condition.

This Amendment will apply whenever the life of any human being is jeopardized. Killing the elderly, human beings with physical/mental conditions, or pre-born children will be affected. Furthermore, specific forms of birth control in which human beings are killed, fertility "selective reduction" during which human beings are killed, and embryonic stem cell research including the use of "frozen embryos," that involves the killing of a human being will be affected.

This Amendment will not apply whenever the life of any human being is not jeopardized. This Amendment will not affect forms of birth control, fertility treatments, or adult stem cell research in which human beings are not killed.
