15 **JUDGMENT**

16 The Defendant, having entered a plea of Guilty, and no sufficient cause
17 being shown by Defendant as to why judgment should not be pronounced against him, the
18 Court rendered judgment as follows:

19 That Jack Albert Schwartz is guilty of the crime of Theft, a violation of NRS
20 205.0832(1)(b) and/or NRS 205.0832(1)(c) and NRS 205.0835(4), a category B felony, as
21 charged in Count I of the Criminal Information, and that he be punished by imprisonment in
22 the Nevada Department of Corrections for the maximum term of one hundred twenty (120)
23 months with the minimum parole eligibility of forty-eight (48) months, with credit for one (1)
24 day time served; by payment of restitution in the amount of Fifty Thousand Dollars
25 (\$50,000.00) to victim VC2212121; in the amount of One Hundred Fifty Thousand Dollars
26 (\$150,000.00) to victim VC2212122; in the amount of Seventy-Five Thousand Dollars
27 (\$75,000.00) to victim VC2212123; in the amount of One Hundred Thousand Dollars
28 (\$100,000.00) to victim VC2212124; in the amount of One Hundred Fifty Thousand Dollars

1 (\$150,000.00) to victim VC2212125; in the amount of Fifty Thousand Dollars (\$50,000.00)
2 to victim VC2212126; in the amount of Thirty Thousand Dollars (\$30,000.00) to victim
3 VC2212127; in the amount of Four Hundred Thousand Dollars (\$400,000.00) to victim
4 VC2212128; by payment of a fine in the amount of Ten Thousand Dollars (\$10,000.00); by
5 submission to a DNA Analysis Test for the purpose of determining genetic markers, if not
6 previously ordered to do so; and by payment of attorney's fees in the amount of Five
7 Hundred Dollars (\$500.00) for reimbursement of legal expenses. Defendant is further
8 ordered to pay a Twenty-Five Dollar (\$25.00) administrative assessment fee and a One
9 Hundred Fifty Dollar (\$150.00) DNA analysis fee to the Clerk of the Second Judicial District
10 Court.

11 The fees and fine are subject to removal from the Defendant's books at the
12 Washoe County Jail and/or Nevada Department of Corrections.
