**WHO MUST REGISTER AS A NONPROFIT CORPORATION  
WITH THE ELECTIONS DIVISION**

A Nonprofit corporation shall submit the names, addresses and telephone numbers of its officers to the Secretary of State prior to engaging in any of the following activities that are designed to affect the outcome of any primary, general, special election, or question on the ballot in the state:

- Soliciting or receiving contributions from any other person, group, or entity;
- Making contributions to candidates or other persons; or
- Making expenditures, designed to affect the outcome of any primary, general, or special election or question.

**If the Nonprofit Corporation will be engaging in political activity,  
please follow the below instructions:**

1. Register a Nonprofit with the Secretary of State's Commercial Recordings Division.
2. Register the Nonprofit form below with the Secretary of State's Election Division.
3. If the Nonprofit is engaging in any of the above activities that are designed to affect the outcome of any primary, general, special election, or question on the ballot in the state:
4. Register as a Political Action Committee (PAC) with the Secretary of State's Election Division, (preferably with the same name as the Elections Nonprofit). This is where to file contributions and expenses reports to comply with NRS 294A.230.
